- 2. Meeting Agenda

 - i. Added a section new business regarding the taking back of \$16K for the social studies computers.

- 5. Treasurer's Report by Tracey Vincent
 - a. Copy of 2023/2024 Year-end Financials is attached.
 - b. The year-end financial statements were also presented at the June 10, 2024 meeting.
 - c. The society had 85K invested in GICs which earned \$750 in interest.
 - d. The society received 81K from the casino and spent almost \$47K to support school projects. A list of the projects can be found on the financial statements.
- 6. By-Law Update Process
 - a. Brian will be updating the bylaws using the AGLCs approved bylaw template. Brian
 is planning on having a draft version to share at October's meeting for discussion.
 Voting on the revised by-laws will take place at November's meeting.
- 7. Spending updates:
 - a. Robotics This project is now complete and the project account is closed.
 - b. Pug Mill Total cost was \$5670

- c. Auto Shop Tools This project is on-going.
- d. <u>Science</u> This project is on-going.
- e. <u>CTS Photography</u> Memory cards are being investigated for this project.
- f. Learning Commons Utilized allocated funds and has \$27 remaining.
- g. Cutting Table (Formerly Forge) Ongoing
- h. <u>Volleyball</u> Almost of the requested equipment has been purchased to date, we are waiting on a few outstanding items.
- i. <u>Social Studies</u> Chrome Books & Cart The school has decided to hand the \$16K back to the society as it is funded for these items next year.
- j. <u>ELA DVD Bluetooth player & Speakers</u> CBE was reluctant to purchase these items due to the dated nature of the DVD technology. The teacher has gone ahead and purchased these items because although the DVD technology is older, the school has several learning tools that work well for students who are ELA. The society will reimburse the teacher directly.
- k. <u>Construction & Cabinet Making Tools</u> This project is now done.
- I. <u>Theatre Lighting</u> We are waiting on one more item to be received and invoiced and then this project will be closed.
- m. <u>Sewing Machines</u> The machines were purchased for \$6K. They were funded for \$7.5K so the additional funds can be rolled back into the society. Project is now closed.
- n. <u>Wrestling Mats</u> This project was approved in June 2023 for \$20K. It will be 38 weeks until the school receives these mats.
