## 4. Principal Report

2025/2026 school year will have student population of 1620 students and 80 staff.

- School start-up has been very smooth.
- New camera system is up and running very well. The footage is intended solely for investigative purposes and not for monitoring student activity
- All teachers are holding tutorials from 8:15AM 8:45AM, Monday through Thursday.

## 5. The Society of Alumni and Friends of Crescent Heights High School

Fran and Lisa spoke about their main fundraising event, the <u>annual golf tournament</u>. The Alumni would like to partner with School Council and Parent Society to help fundraise and provide support outside of the school or Parent Society budgets.
